Mayuenel, late of Epsom, gentleman, being the tenant of those lands, ever since 1 September has allowed the gate to be out of repair.

## **XXV Sessions at Reigate, 16 April 1667**

m.37. Thomas Sands, late of Ewell, knight, on 1 March forcibly diverted, or caused to be diverted, a watercourse flowing by the highway from Ewell to Kingston, from the old channel to his own land.

m.75. From time immemorial here has been a certain paling against a well near the highway in the common waste in Ebbsham; it has been out of repair on and since 10 March. The Inhabitants of Ebbsham should repair the same as necessary.

Sureties: Peter Basemore, baker, and William Bayes, carpenter, both of Ewell.

Memorandum that on 25 August last, Francis Ewell of Ebsham, came before Christopher Buckle and Richard Evelyn, esquires, JPs, at Ebsham; and it appeared that the said Ewell, being then 16 years old and more, had on that date allowed — Knowles, Thomas Bell, late of Allhallows in London, merchant, Benjamin Cole, late of Hammersmith, merchant, John Crosse, late of Great St. Ellens, merchant, Nicholas Holloway, late of Shoreditch, John Vipers, late of St. Mary Whitechappell, Humfrey Jones, late of St. Giles without Cripplegate, Thomas Egg, late of Bishopsgate, and John Penton, late of —, with other (unknown) malefactors and disturbers of the peace, to the number of twenty besides his own family, to congregate at his house for the exercise of religion in a form other than that prescribed for the English Church etc: and the above persons were each and all convicted and fined 5s. by the said Justices. Signed by the Justices, and endorsed: Conventicle taken before Mr. Buckle and Mr. Evelyn.

The Inhabitants of Long Ditton should repair when necessary and have been wont to do so time out of mind.

## **XXX Sessions at Guildford, 14 July 1668**

### **Presentments**

m.26. Sara wife of Thomas Grove, late of Ebsham, yeoman, 16 June, knowing Richard Evelyn, esquire, to be a Justice of the Peace and maliciously intending to bring contempt and ignominy upon him, publicly declared that: 'hee cheates the poore paupers' of the said parish, in grave shame and contempt of the said Richard Evelyn.

m.27. Mary wife of Henry Read, late of Ebsham, yeoman, 16 June, knowing Richard Evelyn, esquire, to be a Justice of the Peace, and maliciously intending to bring contempt and ignominy upon him, and complaining of an injustice done to her by the said Richard Evelyn and being advised by some unknown person to go before another Justice, then and there declared and exclaimed publicly: 'What justice can I expect of a Justice when this is a Justice who cheates the poore pauperes' of the said parish, in great contempt and shame of the said Richard Evelyn.  
Endorsed: John Jordan, Francis Brend, Daniel Wilkinson, John Williamson, John Stephens.

Thomas Grove, husbandman, Thomas Francke, and Samuel Lyn the younger, yeomen, all late of Ebsham, 16 June, with swords, staves etc. made riotous assembly there and broke '*caput fontis Anglice* the Cunditt Head *aque mineralis Anglice* Minerall Water' of Richard Evelyn, esquire, there, to his grave detriment.  
All: Po' se. Cerc' alloc'.

m.31. Henry Read, late of Ebsham, husbandman, 1 September, built a cottage there, for habitation, without assigning to it or laying out 4 acres of land.  
Po' se.

m.32. Edward Read, late of Ebsham, yeoman, 1 September built a cottage there, for habitation, without assigning to it or laying out 4 acres of land.  
Po' se.

m.103. Samuel Lynn the elder, James Pallmer, Henry French, all late of Ebbsham, all labourers, since 1 June have kept each a common tipping house in that parish without a licence from two Justices, selling ale and beer there.  
Lynn and French: Exon' per Act' General' Pardon.  
Pallmer: Po' se. Non cul'.

m.115. George Goodwyn of Dorking, gentleman, 20 April, being Bailiff of Richard Stydolph, Bart., then Sheriff of Surrey, at Ebsham, under colour of his office, illegally exacted from Robert Pike, for the taking and arrest of Robert Wethersby, late of Walton on the Hill, husbandman, 40s., which he, George Goodwyn, kept as his own fee whereas in truth no such fee was due in this case.

m.60. A certain common highway called Tollworth Lane, in Longditton, leading from Ewell to Kingston, has been out of repair etc. since 1 September, for a length of 2 rods. The Inhabitants of Tollworth should repair it, and have been wont to do so from time immemorial.

m.179. 22 December, Herbert Tilley of Ewell, yeoman, £40, to answer.

m.180. 22 December, Edward Powell, Godstone, gardener, £10, to give evidence against Herbert Tilly.

## **XXXVI Sessions at Reigate, 12 April 1670**

## **XXXVIII Sessions at Kingston, 4 October 1670**

Edward Blundell, Thomas Boorne, John Cuddinton, Nicholas Elliot or Elliott, John Jones or Joanes, George Lane or Laine, John Mitchell, Charles Parkhurst, and John Stevens or Steevens, all said to be of Ewell, empanelled among the jurors for the Hundreds of Copthorne and Effingham. m.102. From time immemorial and within the last six years, there has been a common highway in Ebbesham called Ebbesham Common, leading from Stanford Pond there to the Well on Ebbesham Common. Edward Bellgrove of Ebbesham, farmer, within the last six years, has encroached on and inclosed with hedges, gates, etc. for his own gain, a certain part of this highway, 100 x 10 rods, so that since 1 February last it has remained very muddy, foundered and out of repair; and it should be repaired by the said Edward.

m.104. Richard Bellgrove, late of Ebbesham, labourer, 10 August, forcibly assaulted John Stevens there.  
Submiss' et fin' 2s. 6d.

m.108. Thomas Browne, late of Ebbesham, labourer, unmarried and under the age of 30 years, 1 September and at other times, refused to be hired by the year to serve in agriculture, being required by —, yeoman, a Chief Constable of the hundred of Copthorne, and by divers Inhabitants of the said hundred.  
Exon' per Act' General' Pardon.
